FESTUS CITY COUNCIL MEETING MINUTES August 24, 2020

New Business

Fall Clean-Up Date

Councilman Cook made a motion to set the date for the annual fall clean-up for Saturday, October 24, 2020. Motion seconded by Councilman Boyer. Motion carried unanimously.

Request for Honor Glow Event

Dean Eshelman requested permission to hold an Honor Glow event which honors Veterans on September 12, 2020 and to be allowed to hang a banner over Main Street. The Tanglefoot Association is involved with the event and the downtown businesses are doing window displays. Councilman Cook made a motion to approve the event and the banner over Main Street, seconded by Councilman Boyer. Motion carried unanimously.

Budget

City Administrator Greg Camp and Finance Director Stephanie Cunningham reviewed a preliminary draft of the budget with councilmembers. Greg Camp stated the new Public Works Director Matt Unrein will start September 14th and his position will be in with the budget amendment before passage. Greg Camp and Stephanie Cunningham informed Council that this was a preliminary draft and that the budget would be on the next agenda for further discussion. Greg and Stephanie both advised councilmembers that if they have any questions to please give either one of them a call.

Councilman Cook asked Mr. Camp to provide him with a copy of the water rate ordinance and Mr. Camp replied that he would get that for him.

Mayor Richards thanked Finance Director Stephanie Cunningham for doing a fine job preparing this years budget.

Old Business

Stormwater Variance - Pashos Realty

Councilman Cook made a motion to deny the request for a stormwater variance for 501 Brothers Avenue, Festus, Missouri, seconded by Councilman Dennis. Motion carried by the following votes: Ayes (to deny request) – Boyer, Underwood, Wehner, Wilkey, Dennis, Venz, Cook and Tinnin; Nays – none. **Request Denied**.

Reports

Councilman Boyer – Stated that the car cruise happened with over 400 cars participating. Captain Wendel stated the PD did receive some complaints regarding squalling tires.

Councilman Wehner – Stated he was happy to see the Fifth Street Project get moving. Mentioned the police participation regarding speeding and the future use of digital speeding signs.

Councilman Venz – Asked about the Cromwell Project. Greg Camp provided information on the delays of the project and stated that the City has contracted Jokerst to come in as a sub-contractor and get things finished.

Captain Doug Wendel – Stated the police department has been reviewing traffic speed signs and locations.

CLOSED SESSION

Mayor Richards entertained a motion to go into closed session pursuant to Missouri law for the purpose of dealing with matters relating to RSMo. 610.021 (3)(13) Personnel. Councilman Cook made a motion to go into closed session, seconded by Councilman Boyer. Back to Open Session

Councilman Tinnin made a motion that all City employees must wear a mask if they are within six (6) feet of each other for any amount of time and cannot socially distance and when they are riding in a vehicle. Motion seconded by Councilman Underwood. Motion carried unanimously and was to be enforced immediately.

Councilman Cook made a motion to adjourn, seconded by Councilman Underwood. On a call by the chair the motion carried unanimously. Meeting adjourned.
